I have accepted responsibility to verify with my physician that my child/children has/have no physical or psychological problems that would prohibit his/her/their participation in the activity, and agree to advise my child/children to comply with the instructions and directions of the Presenters and their agents, volunteers sponsors, and/or employees. as participants in this event.
